Philanthropic organisation and impact finance: which objectives, forms and instruments of intervention?

Are the prevailing forms and instruments of funding that philanthropic organisations and impact finance make available to cultural and social enterprises adequate to generate effective and lasting interventions?

Is there a need to go beyond disbursement modalities that allocate resources through competitive tenders, tied to specific projects or activities, often requiring targets and indicators of impact and economic sustainability, linked to inappropriate and unrealistic outputs and KPIs?

In order for cultural and social enterprises to pursue significant, medium to long-term cultural and social impact objectives, they need long-term investment to accompany their growth and consolidation and enabling processes to achieve their missions.

Grants, almost-recoverable donations, convertible loans, guarantees, structural investments, non-reimbursable financing, capitalisation, property purchase grants (together with the building of alliances and networks) are some of the alternative forms and instruments that can best support medium to long-term processes and programmes, offering organisations prospects for strengthening, continuity and effectiveness.
